**THE BOOKING**

The reservation becomes effective only after approval of the site and having received your reservation request duly completed and signed. The total amount of your stay must be paid upon booking. Your confirmation will be sent by mail or e-mail after receipt of your payment.

**THE PAYMENT OF THE BALANCE**

The balance must be paid upon your booking. Your reservation is non modifiable or refundable.

**CANCELLATION**

In case of cancellation, no refund will be made.

Your booking is non-refundable and changeable only according to our availabilities.

**DELAY**

In case of delay in the occupation of your booking, your pitch will be retained for a period of **24 hours**. After that period, without information from you, the reservation will be **cancelled without refund**.

**MINOR UNDER 18**

We don’t accept minor under 18 without a legal guardian.

**DEPOSIT**

A deposit of **20 €** will be asked to you at your arrival for the key, and kept by the camping in case of no return.
